1. Participation in rafting involves inherent risks and potential hazards and Queenstown Rafting cannot absolutely guarantee participants safety and certain situations may result in serious harm or death.
2. The risks and hazards include but are not limited to transport to and from the river, the river and its fluid nature, raft flips, fast moving and/or deep water, rocks, landslips and/or equipment failure.
3. I declare that I am a confident swimmer and comfortable in deep water.
4. I declare that I am physically fit, able to participate in Queenstown Rafting activities and have no heart or medical conditions that could be affected by rafting or entering very cold water. I have disclosed to my guide (or will disclose to my guide prior to departure) any heart condition, medical condition, previous injury or medications.
5. I consent to receiving any medical treatment that may be deemed necessary in the event of injury, accident or illness incurred while participating in any Queenstown Rafting activities.
6. I declare that I am not impaired by any alcohol, prescription or other drugs, as being so could seriously compromise my safety and the safety of others.
7. I may elect not to proceed with the trip prior to departure on the river.
8. Queenstown Rafting reserves the right to cancel, reschedule or re-organise trips.
9. Queenstown Rafting may refuse to carry or remove any person for safety reasons.
10. I agree to follow all instructions given by a Queenstown Rafting guide and to use any equipment supplied in accordance with the guide's instructions.
11. I understand that Queenstown Rafting strongly recommends that all visitors to New Zealand should have full insurance covering medical treatment, personal injury and loss or damage to property. I understand that the New Zealand accident compensation scheme only provides limited assistance to non-residents of New Zealand.
12. I agree that to the extent permitted by law, Queenstown Rafting (including management, staff and persons connected to Queenstown Rafting) shall have no liability whatsoever for any direct or indirect loss (including but not limited to injury, death or loss or damage to personal property) sustained by me (or my dependants) during or in any way related to my (or my dependants) participation in Queenstown Rafting activities.
